The Nevada Real Estate Division requires that students to complete a 90-hour real estate salesperson pre-license course before they are eligible to take their state licensing exam and apply for a license. Real Estate Express does not grant credit for previous education and training. Pre-licensing courses may be taken online.

The Division will accept completion of a law degree as meeting the equivalency of the Real Estate Principles course and Real Estate Law course requirements for a real estate license in Nevada. Proof of completion shall be by certified official transcript from an accredited institution.

In general, you should expect your real estate licensing exam to be around 100-150 multiple choice questions; this includes about 60-80 state-specific questions, and about 80-100 questions related to generally universal real estate concepts. You will have between 2-4 hours to complete your exam.
